THE EMERGENCY ASSISTANCE PROGRAM HELPS PEOPLE IN CRISIS BY PROVIDING FOOD, CLOTHING, EMPLOYMENT SUPPORT, AND ONE-TIME FINANCIAL ASSISTANCE WITH RENT, MORTGAGE OR UTILITY BILLS. IN 2016, BCM SERVED 6,752 PEOPLE; DISTRIBUTING 15,599 BAGS OF GROCERIES AND \$95,303 IN CLOTHING. BCM HELPED 238 PEOPLE START NEW JOBS, AND HELPED 557 HOUSEHOLDS PAY RENT, MORTGAGE OR UTILITY BILLS.

70/30 PROJECT (INTERMEDIATE ASSISTANCE):

THE 70/30 PROJECT SERVES LOW-INCOME WORKERS WHO ARE NOT YET HOMELESS, BUT WHO NEED MORE THAN ONE-TIME EMERGENCY ASSISTANCE IN ORDER TO PREVENT EVICTION AND BECOME FINANCIALLY STABLE. IN THIS PROGRAM, BCM PROVIDES TIERED RENT AND UTILITY SUPPORT FOR SIX MONTHS AND PERSONALIZED CASE MANAGEMENT AND VOLUNTEER MENTORSHIP WHILE CLIENTS: 1) PARTICIPATE IN BCM'S MONEY MANAGEMENT COURSE; 2) ESTABLISH A HOUSEHOLD BUDGET; AND, 3) BEGIN TO PAY DOWN DEBT. IN 2016, 19 HOUSEHOLDS COMPLETED THE PROGRAM. THESE PARTICIPANTS COLLECTIVELY PAID DOWN OVER \$76,871 IN PERSONAL DEBT WHILE IN THE PROGRAM.
