BCM ALSO PARTICIPATED IN THE UNITED WAY 1.0 PROJECT, DISPENSING OVER A MILLION DOLLARS FOR RENTAL ASSISTANCE DUE TO COVID-19.

IN THIS PROGRAM, BCM PROVIDES TIERED RENT AND UTILITY SUPPORT FOR SIX MONTHS AND PERSONALIZED CASE MANAGEMENT. THE PROGRAM PARTICIPATES ENROLLED IN A 22- WEEK FINANCIAL LITERACY PROGRAM AND PAIRED WITH A FINANCIAL COACH. THEY ARE REQUIRED TO ESTABLISH A HOUSEHOLD BUDGET, PAY DOWN DEBT, OPEN A SAVINGS ACCOUNT AND START SAVING.
